Privacy Notice Trustees, Advocates, Governance & Volunteers

1. Privacy Notice (How we use information)

Dartmoor Multi Academy Trust collect, hold, use, and share information about our workforce. This is known as “personal data” and you have rights around that data, including knowing how and why we are processing the data. “Processing” data means from collecting, storing, using, sharing and disposing of it. We collect, hold and share personal information on the local governing board members, trustees and volunteers.

For the purposes of Data Protection legislation Dartmoor Multi Academy Trust and its schools is a data controller and is registered as such with the Information Commissioner's Office.

2. The categories of governance information that we process include

- Personal identifiers, contacts and characteristics (such as name, date of birth, contact details, address and photograph)
- Governance details (such as role, start and end dates)
- Information about medical or health conditions, including whether you have a disability for which the school needs to make reasonable adjustments
- Checks made regarding online presence including social media searches

We may also collect, use and store information about criminal convictions, offences and prohibitions. This information may have come from other organisations including former employers, Teacher Regulation Agency, social services and the Disclosure & Barring Service.

3. Why we collect and use governance information

The personal data collected is essential, for the trust to fulfil their official functions and meet legal requirements.

We collect and use governance information, for the following purposes:

- a) to meet the statutory duties placed upon us
- b) facilitate safer recruitment (e.g. by carrying out criminal records checks)
- c) to help us to deliver our responsibilities to our school community
- d) to communicate with our Governing body
- e) to inform the school community of the identity of the individuals who comprise the Governing body
- f) photographic images for identification purposes (safeguarding and identifying Governing Boards to our parents and pupils), and celebration purposes (to record school events)

Under the General Data Protection Regulation (GDPR), the legal basis we rely on for processing personal information for general purposes are:

- Article 6(a) – Consent (for any processing which does not fall into the bases detail within this section below)
- Article 6(c) – Compliance and Legal Obligation
- Article 6(e) – Public Interest.

All school governing bodies, under section 538 of the Education Act 1996 and academy trusts, under Academies Financial Handbook have a legal duty to provide the governance information as detailed above.

Keeping Children Safe in Education (statutory guidance from the Department for Education issued under Section 175 of the Education Act 2002)

The ways we collect and use *sensitive* information about governing board members are lawful based on: your explicit consent; for compliance with certain legal obligations, or for exercising certain legal rights; for protecting a person's vital interests in an emergency; for health and public health reasons; or for carrying out tasks that are in the substantial public interest including for safeguarding purposes. Please refer to our Special Category Data Policy document for full details of these lawful bases for processing this data. Types of data that are special category are indicated above by *.

Marketing Purposes

Where you have given us consent to do so, we may send you marketing information by text message or email promoting school events, campaigns and or charities. You can withdraw this consent at any time by contacting us (see the Contacts section) or by emailing governance@dmatschools.org.uk.

Automated decision making & profiling

We do not currently process any personal data through automated decision making or profiling. Should this change in the future, privacy notices will be updated to explain both the processing and your right to object to it.

4. How we collect governance information

We collect personal information via this information in a variety of ways. For example, data is collected through application forms, obtained from your passport or other identity documents such as your driving licence, from forms completed by you at the start of or during your term as a Governing board member, from correspondence with you, or through interviews, meetings or other assessments, images provided by you or taken using school photographic equipment, local authorities, the NHS, the Police, the Disclosure and Barring Service and the Department for Education.

Governance data is essential for the school's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

5. How and where we store governance information

We securely store workforce information on the Trust's cloud-based secure storage (GovernorHub and Office 365). Secure storage is provided for paper-based records. We hold data securely for the set amount of time shown in our [Records Retention Deletion policy](#).

6. Who we share governance information with

We routinely share this information with:

- GovernorHub
- Trust intranet
- The Department for Education
- The Disclosure and Barring Service
- Our school community (via the Trust website)

7. Why we share governance information

We do not share information about our workforce members with anyone without consent unless the law and our policies allow us to do so.

8. Department for Education

We share personal data with the Department for Education (DfE) on a statutory basis. We are required to share information about our governing board members with the Department for Education (DfE) under Section 538 of the Education Act 1996.

9. Freedom of Information Act and Environmental Information Regulations 2004

As a public body, our school is subject to requests made under the above legislation. Therefore, we have a legal obligation to process any personal data we hold when considering requests under these laws.

For example, we may receive a request asking about numbers and/or roles of governing board members.

However, we will never disclose personal data in our responses to these requests where to do so would contravene the principles of data protection.

10. Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information, contact the School Office, the Headteacher or the Data Protection Officer.

You also have the right to:

- be informed about the collection and use of your personal data

- rectification, i.e., to have inaccurate personal data rectified, or completed if it is incomplete
- erasure, often known as the 'right to be forgotten'; however, this does not apply where, amongst other things, processing is necessary to comply with a legal obligation.
- restrict processing, although, as above this is a limited right
- object; though other than for marketing purposes, this is also limited as above
- Where we rely on your consent to process your data, you have the right to revoke that consent
- You also have rights in relation to automated decision making and profiling, though these are not currently relevant
- Finally, the right to seek redress, either through the ICO, or through the courts

11. How Government uses your data

The governance data that we lawfully share with the DfE via Get Information About Schools (<https://get-information-schools.service.gov.uk/>):

- will increase the transparency of governance arrangements
- will enable maintained schools and academy trusts and the department to identify more quickly and accurately individuals who are involved in governance and who govern in more than one context
- allows the department to be able to uniquely identify an individual and in a small number of cases conduct checks to confirm their suitability for this important and influential role.

Note: Some of these personal data items are not publicly available and are encrypted within the GIAS system. Access is restricted to a small number of DfE staff who need to see it in order to fulfil their official duties. The information is for internal purposes only and not shared beyond the department unless law allows it.

12. Sharing by the Department of Education

The Department for Education (DfE) collects personal data from educational settings and local authorities. We are required to share information about individuals in governance roles with the Department for Education (DfE), under:

We are required to share information about individuals in governance roles with the (DfE) under the requirements set out in the [Academy Trust Handbook](#).

All data is entered manually on the GIAS system and held by DfE under a combination of software and hardware controls which meet the current government security policy framework.
